Lectures:

There are 36 online assignments using Pearson's *MyLab Math*. You can access *MyLab Math* through your section's Brightspace page. Due dates for the assignments are set by the individual instructors. There are also handwritten problems to be found in *MyLab Math*. Your instructor will inform you of due dates and how to turn your handwritten problem sets in.

Policy on Late Homework:

Except in cases of University approved reasons, late homework will not be accepted. At the end of the semester, the *3 lowest online homework scores will be excused*. No handwritten scores will be dropped.

Homework Score Appeal:

If you believe there is a computer error in the grading of your homework problems, please contact your instructor by email.

The *maximum* percentages to get each grade are:
